## **RECIPIENT GENERATED TAX INVOICE**

Applicants that do have an ABN and are registered for GST will receive automatic payment on the approval of the grant and should tick YES on the grant application form under Section 1, Registered for GST 'Do you provide consent Corangamite Shire Council to generate a recipient created tax invoice for the purpose of Community Grants funding payment?'.
