Incident Situation and Update

How long does it take to extinguish a peat fire? Peat is an organic fuel consisting of spongy material formed by the partial decomposition of organic matter, primarily plant material, in wetlands such as swamps, bogs and lake beds.

Dried peat burns readily with a smoky flame and a characteristic odour. The ash is powdery and light with an orange colour when burnt with a high heat, except for varieties that have a high content of inorganic matter.

Because of this vast accumulation of fuel, once ignited, smouldering peat fires may potentially burn for very long periods of time (e.g. weeks, months, years) despite extensive rains, weather changes or fire-fighting attempts.

Thanks to the amazing efforts by all crews involved we are seeing some great results in getting on top of the peat fires in Lake Cobrico and Lake Elingamite.

There is still work to be done to fully extinguish these fires, which at this stage is mainly confined to a number of hot spots. Thank you to everyone involved particularly the community members, for your assistance, understanding and patience. We understand how difficult this has been for many. We are here, and be assured we will remain here in some capacity until the job is done! To reflect our success in the fire and smoke suppression efforts, the Incident Control Centre (ICC) will be relocating from Warrnambool to Cobden on Friday 27 April to enable the Incident Management team to be closer to the firefighting operation and impacted communities. Additional portable buildings and infrastructure have been placed into the Cobden Fire Station to enable to the Incident Management Team (IMT) to work effectively from that location.

The IMT would also like to thank the Cobden community for their continued and ongoing support of both the crews based at the Staging Area in Cobden and the members of the IMT who will be located at the Cobden LCF on Station Street.

Air monitoring Carbon Monoxide (CO) monitoring results from the three Environment Protection Authority (EPA) sites at Cobden, Lake Cobrico and Lake Elingamite are returning values well below health trigger levels. The EPA plans to decommission the air monitoring sites in the coming weeks. The monitoring site at Cobden, which monitors a larger area, will remain and continue monitoring until further notice. If members of the community are in any way concerned with the proposed decommissioning of the air monitoring sites, please call the ICC on (03) 5559 2345 from tomorrow (Friday 27th April 2018).

With the cessation of the fire danger period approaching, please consider delaying your burn off to reduce the incidence of smoke drift.
